### Remarks regarding the Price List for Primary and Secondary School, School Year 2024/25

1. The **SIS Profile** covers bilingual education including lesson times from 7:30 a.m. to 5 p.m. Attendance for lessons between 8:30 a.m. and 3 p.m. is mandatory for all students in the SIS Profile. Starting in grade 9, obligatory attendance times may be extended. Outside the compulsory lesson time, students can choose from a variety of bilingual extracurricular activities, for instance various sports and exercise clubs, breakfast, afternoon snack, time to read or relax as well as study time. A hot lunch is available for an additional fee. Booking of the SIS Profile is for one year and is automatically renewed for another year unless cancelled in due time. It is possible to change from the Basic Programme to the SIS Profile during the school year at the first of every month.
2. Fees for the **Basic Programme** cover times from 8:15 a.m. to 12 p.m. and 1:30 p.m. to 3 p.m. (Primary School) or 8:15 a.m. to 12:45 p.m. and 1:30 p.m. to 3 p.m. (Secondary School) respectively. During this time, attendance is compulsory. Starting in Grade 9, obligatory attendance times may be extended; if applicable, these are also included in the fees. Students registered on the Basic Programme may be dropped off at school at 8:15 a.m. at the earliest. They must leave the school premises between 12 p.m. (Secondary School: 12:45 p.m.) and 1:30 p.m. and at 3 p.m.
3. SIS strives for a balanced mixture of students from different familial backgrounds. Therefore, the **school fees are income based**. Fees are based on the annual (worldwide) gross family income of the previous calendar year (2023). Every family is obliged to fill out the "Evaluation Form of Family Income" on a yearly basis and send it back to SIS in due time, together with the applicable supporting documents. Family income includes, amongst others, salaried or self-employed income, income from rent or investments, child benefit, alimony and tax free earnings. Negative income cannot be deducted from positive income. All supporting documents have to be in German or English. Costs for a possible translation must be covered by the family. If the evaluation form of family income and / or the supporting documents are not provided on the given due dates, SIS will charge the maximum rate.
4. Families receive a **sibling discount** in fees for the SIS Profile or the Basic Programme by 5% for the second or third child enrolled at SIS. The one-time entrance fee as well as the expenses incurred for the additional services are not affected by this reduction.
5. **After School Care** from 5 p.m. to 6 p.m. is an additional offer and shall be covered by a separate arrangement. You can take advantage of this offer for one or more (up to five) weekdays. Please note that the booking of specific weekdays within the After School Care cannot be changed for at least one school semester (Sep 1 - Feb 28/29 and March 1 - Aug 31). Additional days can be booked during the course of the year. This has to be coordinated and approved by the principal and depends on whether a place is available.
6. **Lunch** as well as **After School Care** are only available in conjunction with the SIS Profile.
7. You have the option of purchasing lunch from an external provider. Please contact the school office for further information.
8. All fees are monthly average rates based on calculations for 12 months per year (respectively 6 months per semester). This means payments are due **12 months per year**, including the holidays. All fees must be paid as a lump-sum, regardless of whether a family makes use of individual services. Payment of fees needs to be made one semester in advance. For monthly payment rates, there will be a surcharge of 3% on each payment. Parents who make an advanced payment covering the whole school year will be offered a 2% discount. SIS will ask parents about their preferred mode of payment; any subsequent change involves an administration fee, which is 50 € for each invoice to be changed (respectively for each invoice line item within collective invoices).
9. The **one-time entrance fee** is due upon signing the school contract and is non-refundable.
10. Costs for **text books** are included in the school fees. **Costs** arising from **class trips, excursions** etc. as well as the **assessment fees for the IB Diploma** in grade 12 are **not** covered by the school fees.
11. SIS follows the **Baden-Württemberg / Friedrichshafen school calendar**.
12. Please note that contents referring to booking and terms of payment are provisional. Detailed and legally binding modalities will be outlined in the school contract and, if applicable, additional agreements. The listed fees are valid for the school year 2024/25. The school reserves the right to adjust its fees.
