## Remarks Price List for Primary and Secondary School 2022/23 School Year

1. The monthly fees cover tuition and supervision from 7.30 a.m. to 4.00 p.m. For students in primary school and secondary school **attendance** from 8.30 a.m. to 3 p.m. is **mandatory**. Starting in grade 6, obligatory attendance times may be extended.
2. SIS strives for a balanced mixture of students from different family backgrounds. Therefore, the **school fees are income based**. Fees are based on the annual (worldwide) gross family income of the previous calendar year (2021). Every family is obliged to fill out the "Evaluation Form of Family Income" on a yearly basis and send it back to SIS in due time, together with the applicable supporting documents. Family income includes, amongst others, salaried or self-employed income, income from rent or investments, child benefit, alimony and tax-free earnings. Negative income can not be deducted from positive income. All supporting documents have to be in German or English. Costs for a possible translation must be covered by the family. If the evaluation form of family income and / or the supporting documents are not provided on the given due dates, SIS will charge the maximum rate for the entrance fee and the school fee.
3. Each year, Wintershall Holding GmbH funds a number of **scholarships** which shall provide children of low-income families the opportunity to visit the SIS Swiss International School Kassel. Please contact the principal for further information about the application process and the relevant deadlines.
4. You have the option of purchasing **lunch** from an external provider. Please contact the school office for further information.
5. Families receive a **sibling discount** in tuition fees by 10% for the second or third child enrolled at SIS. The one-time entrance fee as well as the expenses incurred for the hot lunch programme and other additional services are not affected by this reduction.
6. **After School Care** between 4.00 p.m. and 5.00 resp. 6.00 p.m. is an additional offer and shall be covered by a separate arrangement. You can take advantage of this offer for one or more (up to five) weekdays. Please note that the booking of specific weekdays within the After School Care cannot be changed for at least one school semester (Sep 1 - Feb 28/29 and March 1 - Aug 31). Additional days can be booked during the course of the year. This has to be coordinated and approved by the principal and depends on available resources.
7. All fees are monthly average rates based on calculations for 12 months per year (respectively 6 months per semester). This means payments are due **12 months per year**, including the holidays. Payment of fees needs to be made one semester in advance. For monthly payment rates, there will be a surcharge of 3% on each payment. Parents who make an advanced payment covering the whole school year will be offered a 2% discount. SIS will ask parents about their preferred mode of payment; any subsequent change involves an administration fee, which is 50 € for each invoice (resp. for each invoice line item within collective invoices) to be changed.
8. The **one-time entrance fee** is due upon signing the school contract and is non-refundable.
9. Costs for **text books** are included in the tuition fees.
10. **Costs** arising from **class trips, excursions** etc. are not covered by the school fees.
11. SIS follows the **Hessian resp. Kassel school calendar**.
12. Please note that contents referring to booking and terms of payment are provisional. Detailed and legally binding modalities will be outlined in the school contract and, if applicable, additional agreements. The listed fees are valid for the school year 2022/23. The school reserves the right to adjust its fees.
